Indigenous Peoples and Impact Assessment Principles

There are over 300 million Indigenous Peoples in the world, and many live in biodiversity hotspots and ecosystems that are the focus of intense extractive industry development. History has shown that involvement of Indigenous Peoples in resource and infrastructure development projects that affect them has been done very poorly. When Indigenous Peoples and their knowledge systems are properly respected and acknowledged in the development process, the benefits of involvement generally surpass the planned outcomes.

Companies can realize solutions to problems otherwise difficult to resolve, and Indigenous Peoples' self-determination and capacity can be enhanced. At IAIA08 the Indigenous Peoples section had a very interesting and dynamic meeting. One of the decisions of that meeting was that the Indigenous Peoples Section should develop a document for IAIA titled "Indigenous Peoples Involvement: International Best Practice Principles."

Bua Port Environmental Impact Assessment: Helping Secure a Future for Rural Fiji

A remote region of Fiji, Bua exists primarily through subsistence agriculture. Fiji's Department of Fisheries and Forests (DFF) initiated the Bua Port project to help stimulate the timber industry on Bua. It was one of the first significant construction projects in Fiji under the 2004 Environment Management Act, which was enacted to protect natural resources and help manage developments.

The DFF, Department of Environment (DoE), and consultants worked closely to prepare the assessment, which included technical assessments of geology, coastal processes and hydrodynamics, ecology, water quality and economic and social impacts. The remote location was challenging. Consultation specialists spent a week onsite with a Fiji team who translated concepts into the local dialect.

A key to success was taking conventional IA best practice techniques and applying them where interpretations of new legislation had not yet been established. Achieving inclusive consultation in such a remote location was a real accomplishment, and the DoE director said this resulted in an informed community with a greater acceptance of the project. • Lucy Brake, Beca Group Ltd. International Cooperation for a Sustainable World

The current economic turmoil has been creating huge impacts all over the world, as the contemporary economic system is borderless and well connected. Industries might be inclined to pay less attention to environmental impacts, but considering the mishandling of financial activities not only in the U.S. but also in other parts of the world, we need to reconsider the role of financing and the real goal of economic efforts.

Japan experienced significant economic growth after World War II based on the development of science and technology and intensive investment in education. In the beginning stage of its economic progress, Japanese economic activities were supported by necessary infrastructures such as expressways, irrigation systems, the high speed train (Shinkansen), and so forth, with the help of financing from the world, especially from the World Bank. Japan could make progress not only by science and technology and ability of the workers, but also by this kind of international cooperation.

To create a sustainable society is a common goal in every part of the world. By pursuing this goal in each area, we could finally construct a sustainable world. Japan has been very active in international cooperation after catching up in the 1960s, and the current target of the activity is this goal. The Japan International Cooperation Agency (JICA) changed its structure and function in October 2008, by merging the Yen Loan Division of the Japan Bank for International Cooperation (JBIC). The financing of JBIC is limited only to private companies now. JICA also had taken a major part of providing gifts from the Japanese government to developing countries at the same time. JICA became an extraordinarily great organization in official development assistance (ODA) in the world. The annual budget of the new JICA is 10 billion US dollars, which is second largest in the world and more than half of that of the World Bank.

Because of this situation, the activities of JICA need to take more environmental and social consideration. Actually, JICA has been preparing to revise its present guidelines, just as JBIC has done recently. As the activity of the new JBIC was simplified by the shift of the ODA function to JICA, it was much easier for JBIC to revise the guideline than JICA. JICA has now three functions: technical assistance, Yen Loan and gift. It is quite nice that JICA could conduct ODA activities efficiently by combining these three functions. But it is also problematic as the activity become more complex than before. It therefore creates difficulty in revising the existing guideline for the new JICA. My colleagues and I have been advising on the revision of the guidelines as experts. I, as the chairman, submitted the interim report of the advisory committee to JICA last December. As of March 2009, JICA staff are still drafting the revised guidelines. The draft will be examined in committee soon. I hope it will become a more advanced guideline for creating sustainable societies.

The photos below show a comparison of land use patterns in New York and Tokyo, the two biggest metropolises in the world, which was taken by me for my TV program on impact assessment. There

IAIA Participates in Launch of Coalition To Address Human Rights Concerns

The American Association for the Advancement of Science (AAAS) has launched a new coalition to foster communication and partnerships on human rights among scientific associations and between the scientific and human rights communities. IAIA was represented by **Gene Owens** and **Anne Miller**.

The Coalition is an initiative of the AAAS Science and Human Rights Program and was launched during a recent three-day conference in Washington, DC, USA. It is a network of scientific societies that will work together to tackle human rights concerns. Through the Coalition, members will share their work on human rights, explore discipline-specific contributions, and take human rights programs to interested scientific associations.

Within the Coalition are five working groups that will focus on specific areas of activity: Welfare of Scientists, Science Ethics and Human Rights, Service to the Scientific Community, Service to the Human Rights Community, and Education and Information Resources. The Coalition is particularly interested in having its membership as a whole work to promote the rights of everyone to the benefits of scientific progress—innovation and technology—at home and around the world.

It will be worthwhile to follow this initiative in order to identify possible future linkages. Certainly, Environmental Impact Assessment has played an extremely strong role in encouraging and/or requiring public participation, which may then occur in other elements of civil society as well, and working to ensure that people (and the rest of the natural environment) are protected from adverse impacts of human activity. A poster and handouts regarding the upcoming IAIA09 meeting in Ghana, "Impact Assessment and Human Well-Being," were made available at the initiative's launch. is a clear contrast of the cities. The land use of the central parts of the two cities has no big difference. But only 10km away from the central area, we see a big difference. Why did this happen? It was because of the difference in planning. In New York, they made a strategic plan for the metropolitan area in 1929, the year of the Great Depression. In Tokyo, we had no strategic plan since the period of the rapid economic growth after the War. The area was developed under insufficient planning administration in Japan.

We could learn from this how a strategic approach is necessary. It is especially important in countries where rapid economic growth has been realized and metropolitan areas are expanding. We observe such phenomena in many developing countries. In ODA activities, we should draw a lesson from the failure of the Tokyo area and help developing countries to make strategic plans. Impact assessment experts know that we have an effective way for this: it is strategic environmental assessment, or more recently, sustainability assessment. Future ODA should include such a strategic approach. I will continue to advise JICA to steer the guidelines in this direction.

IAIA is a valuable network to support this kind of activity by providing input from all over the world. We will have the annual conference in Accra, Ghana, this May, under the theme of "Impact Assessment and Human Well-Being." It should be a wonderful occasion to consider international cooperation for creating a sustainable world.

Nearly 90 papers covering various aspects of SEA from different parts of China were submitted. With the sponsorship of the Hong Kong Institute of Environmental Impact Assessment (HKIEIA), we organized the "Best Paper Award for Young EA Practitioners" and were able to present five such awards at the closing ceremony.

Scotland and Northern Ireland Conference on Strategic Environmental Assessment (SEA): Getting Better Value from SEA

"Getting Better Value" was the theme at the heart of the Scotland and Northern Ireland Conference on Strategic Environmental Assessment (SEA). The one-day conference explored SEA in the context of the sustainability agenda of Scottish local government and in terms of SEA's ability to add value and efficiency to the planning system. Held in Glasgow on 20 October 2008, it was part of the wider involvement of the David Livingstone Centre for Sustainability (DLCS), University of Strathclyde, in policy related research, teaching and consultancy.

The conference was organized by doctoral researcher **Anna McLauchlan** and chaired by senior lecturer Dr. **Elsa João**, both of DLCS. The conference attracted 112 delegates from central government, local government, environmental consultancies, non-governmental organisations and academia. The objective of UNEP's Green Economy initiative is to enable global leaders and economic, finance, trade, environmental and other policymakers to recognize environmental investment's contributions to economic growth, job creation, and poverty reduction. The initiative will communicate a global plan for a green industrial revolution to be supported by strong evidence for investment into a new generation of green assets. To prepare societies for a transition toward green economies, impact assessment will be crucial to influencing and shaping macroeconomic green policy development, which will in turn play a major role in addressing the global economic crisis. UK Commissions Research on Noise and Environmental Impact Assessment

The UK's Department for Environment, Food, and Rural Affairs recently appointed a consultancy to review effectiveness of planning processes in assessing noise with regard to human health, flora, fauna and the built environment. The study will focus on how EIA addresses noise impacts, considering both the environmental statement and the outcomes after development is completed. The project will assess both the technical quality of the noise section of the environmental statement, and whether the impacts are sufficiently described for the benefit of those who might be affected. Post-development, the study will review how well impacts were predicted, if mitigation was effective, and any unexpected noise issues. EIA procedures in other EU member states will also be compared to the UK process, and consideration given to any effects on current planning processes from noise action planning under the European Noise Directive. The team desires to hear of relevant examples, observations or case studies relating to other EU member states. EIA vs. Economic Stimulus in California

For the third year in a row, California's 28-year old comprehensive EIA law, the California Environmental Quality Act (CEQA), is at the center of negotiations to resolve the state's \$42 billion budget shortfall. Republican legislators, with the support of groups representing homebuilders and infrastructure construction contractors, are refusing to approve a state budget, in part, unless the requirement to assess greenhouse gasses are removed from CEQA, and unless major public infrastructure projects funded by state economic stimulus moneys are exempted from CEQA review. Governor Schwarzenegger also has proposed retroactive exemptions of 10 major transportation projects from CEQA, and has petitioned President Obama to exempt major federal infrastructure projects from NEPA review. As of this writing, it is unclear how this perceived conflict between environmental assessment/protection and economic stimulus will be resolved. • Richard Grassetti • gecons@aol.com

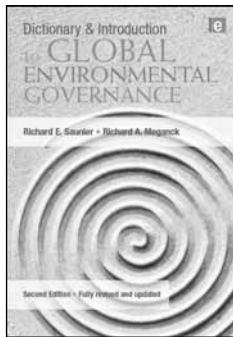

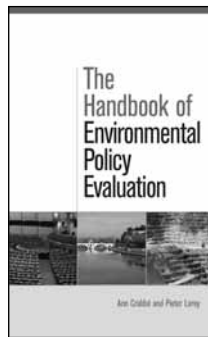

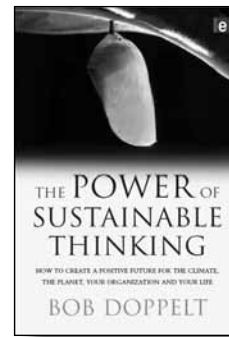
