## UNECE – EIA AND SEA IN A TRANSBOUNDARY CONTEXT – MOP5/MOP1

The 5th Session of the Meeting of the Parties to the Convention on Environmental Impact Assessment in a Transboundary Context (MOP5) and the 1st Session of the Meeting of the Parties to the Protocol on Strategic Environmental Assessment (MOP1) were held in Geneva between 20 and 23 June 2011. The two meetings were run in parallel, with several common points on the agenda. Two events organized during the MOP5/MOP1 are worth to be mentioned. One was a seminar with eminent law experts (Alan Boyle, Jonas Ebbesson, Simon Marsden, Jan de Mulder, Neil Craig and Jerzy Jendroska) that addressed the 20 years of law and practice under the Convention. The experts debated several issues and law cases, including the already extensively debated Bystroe case, or the Ukrainian-Romania conflict concerning the Ukrainian exploitation of the Danube – Black Sea channel. This is a long-debated case for the past nine years which could become an extremely interesting EIA law case to be explored and lessons taken for the benefit of the IAIA membership. A second event was the Panel discussion on nuclear energy-related projects, moderated by George Kremlis of the European Commission, a highly relevant theme in face of the coming IAIA12 Conference on Energy Futures, to be held in Porto, Portugal in May 2012. Outcomes of that discussion summarized by George Kremlis may represent opportunities for possible future IAIA involvement. ## UK GOVERNMENT RELEASES NATIONAL ECOSYSTEM ASSESSMENT— BUT IS IT A STEP FORWARD OR A POLITICAL DIVERSION?

The British government has just announced the completion of its National Ecosystems Assessment, but critics already accuse the government of attempting to set a price for everything while knowing the value of nothing. What significance will this new study have on the scope and content of future EIAs and the formal analysis of the costs and benefits of new and old projects?

Many project EIAs fail to consider the value of “free” ecological services. This results in systematic overestimation of benefits and minimizes the predicted scale and costs of damage limitation and remediation. Now, for the first time, the UKNEA offers a framework for including these services in quantitative terms in environmental cost-benefit analysis.

But does this really reflect the importance of environmental intangibles? Already the new study is facing mixed receptions. The public sector views this study as a step forward, but dissenting voices suggest that it is merely a politically-inspired diversion that will increase governmental reliance on simplistic economic analysis while decreasing recognition of the importance of non-quantifiable social and ethical concerns.

The study relied on the expertise of a formidable range of professional ecologists, so it appears to have substantial expert pedigree, but concern is growing that it will boost political support for controversial development proposals by depending on meaningless estimates of economic values when non-quantifiable issues are of greater relevance.

## OECD DAC COMPLETES ADVISORY NOTE ON SEA AND BIOFUELS

The OECD DAC (Organization for Economic Cooperation and Development – Development Cooperation Directorate) Task Team on SEA has recently completed an Advisory Note on SEA and Biofuels. This Advisory Note illustrates how SEA can be used as a tool to facilitate sound decision-making to ensure long term sustainability of biofuel development. This can be achieved through identifying the wider environmental and social considerations associated with different stages of the biofuel development.

Currently, the Task Team has developed Advisory Notes for SEA and climate change adaptation, biofuels, ecosystem services, disaster risk reduction and post-conflict development. ## IAIA 11 BY THE NUMBERS

Preliminary results from IAIA11 conference evaluations

The IAIA11 online conference evaluation survey closed 11 July, and we are still assessing the data. Because the survey was also bilingual, we are also still translating some of the open-ended responses. However, we wanted to share a few of the early results.

Of the total 592 delegates attending IAIA11, 218 completed the conference evaluation, for a 37% response rate. Of the respondents, 94% were satisfied or very satisfied with the overall conference, and 98% would recommend future IAIA conferences to colleagues.

Half of all respondents learned about IAIA11 via their membership in IAIA. However, of first-time IAIA delegates, 66% of respondents learned about the event via a friend or colleague.

Similar to previous years, a majority of delegates felt the time allocation for plenaries, theme forums, concurrent sessions, social/networking events, and the overall conference itself should remain the same. Respondents had the opportunity to indicate the number of days they would prefer

the overall conference to be, and answers ranged from only one day up to 12 days.

Delegates were generally satisfied or very satisfied with green initiatives at IAIA11, although they felt IAIA should make information about where and when to return name badges more visible and do more to encourage delegates to purchase carbon offsets for their travel. (Of the respondents, only 4% purchased carbon offsets for IAIA11 travel.) We appreciate the many suggestions offered for “greening” IAIA conferences, and, as always, we will review and implement them to the extent possible at future events.

While many respondents thought that the Section meetings, Council meeting, and Annual General Meeting provided adequate opportunity for input into the overall operation of IAIA, many people did not know about these events, particularly among first-time attendees. IAIA will work to increase awareness of these events and inform delegates why they might want to attend them.

Over two-thirds of the respondents would like the proceedings to include PowerPoint presentations (74%), text of keynote speeches (69%) and the optional 5-page papers (69%), and we are doing our best to accommodate those wishes. We have already begun posting some of the presentations online as they are submitted (<http://iaia.org/conferences/iaia11/proceedings>), along with some photos and videos as well.

For 47% (96) of the respondents, IAIA was their first IAIA conference. While 30% had attended 1 to 4 IAIA conferences before, 15% had attended 5 to 10 IAIA conferences previously, and 8% had attended 11 or more IAIA conferences.

28% of delegates were from consultancies/private consultants, 23% from government, 15% from education, 10% from research institute or laboratory, and 9% from industry.

## NETWORK WITH IAIA MEMBERS THROUGH CONNECT



**By the end of September, all current IAIA listservs will be discontinued, and all Section communications will take place on IAIAConnect.**

On IAIA conference evaluations, “networking” is consistently listed as the #1 conference benefit. IAIA wanted to expand and enhance this benefit to all members, regardless of whether or not they could attend an IAIA conference. At the same time, the IAIA Sections wanted a replacement for the existing listservs. After exploring options and consulting the Sections, IAIA launched a new professional networking site in October 2010. So far, we have received some very positive feedback. In fact, some members have enjoyed “rediscovering” fellow members by seeing their profiles on Connect and reconnecting with them.

While IAIAConnect replaces the basic communication function of the existing listservs, it offers much more to our members. Unlike with listservs, the messages and replies on IAIAConnect are archived and accessible, much like an electronic bulletin board. Members can upload resources, collaborate on wiki documents, post event notices, and add a profile picture. Because IAIAConnect is integrated with our membership database, members can easily search for and view each others’ profiles, so it serves as a membership directory as well. Activity on the site can be sent to members via e-mail notifications, with either a daily or weekly digest.

Since October 2010, IAIAConnect activity has been steadily increasing, and even more so since IAIA11. As with the previous listservs, some groups on IAIAConnect are more active than others, but we look forward to increased activity as members have an opportunity to log in, explore, and discover new ways to engage and benefit from the features the site has to offer. Want to ask a question of all IAIA members, get Section members’ opinions on a topic, or continue a discussion started at IAIA11 to involve those who didn’t attend the conference? Log in at <http://iaiaconnect.iaia.org>, choose a group, and post your question.

By the end of September, all current IAIA listservs will be discontinued, and all Section communications will take place on IAIAConnect. Because the listservs include both IAIA members and non-members, a message will be sent to each listserv about the upcoming change. While only IAIA members are allowed to post, reply and upload to IAIAConnect, non-members will still be able to view discussions, announcements and resources posted there.

## IN MEMORY

**Desmond M. Connor** longtime IAIA member and original chair of the Public Participation Section, died 17 May 2011 in Victoria, British Columbia, Canada, where he lived with Etta, his wife of 53 years.

Des was an applied sociologist-anthropologist with an international practice in preventing and resolving public controversy for corporations and government agencies which were proposing new policies, programs and projects. He was responsible for completing more than 300 projects, mostly in Canada but a number overseas, through his company, Connor Development Services Ltd., which he founded in 1968. He also taught as an adjunct professor at the University of Victoria, designed courses at colleges and universities and wrote books and manuals.

His gentle manner, initiative, and thoughtful input to IAIA activities will be warmly and gratefully remembered.
