

Submission Instructions

1. Title of submission.
2. Specify format. Paper, poster, or workshop/session.
3. Complete name(s) of author(s) and complete contact information for each author (organization, street address, city, state/province, postal code, country, phone, fax and e-mail, URL if applicable). Contact information will be published as provided by the author.
4. Name of presenting author. All correspondence will be directed to this person.
5. Abstract. 300 words maximum. Excess will be deleted.
6. Key words.
7. Indicate under which conference topic you would like to submit your paper (paper submissions only). Feel free to suggest topics not already listed.
8. Any brief additional information you think may be useful to the Program Committee, including the link with the major theme of the conference.

Deadlines

- 15 August 2003 (workshops/sessions)
- 15 October 2003 (paper and poster abstracts)

How to Send

E-mail is preferred. Place your abstract (plain text only) in the body of the e-mail message. Do not send attachments. In the subject line, write **primary author's last name-04 abstract** (Example: McDonald-04 abstract). You may submit more than one abstract; however, only one abstract per e-mail, please.

Acceptance & Registration

Please allow 2-3 weeks for IAIA HQ to notify you that your abstract has been received, and reviewed according to Program Committee guidelines. Following preliminary acceptance by HQ, the presenting author is required to submit the registration form and full conference fees before the submission will be confirmed on the final program by the Program Committee.

The deadline for presenter registration is 28 February 2004. After that time, submissions with the presenting author not registered will be dropped from consideration.

REMEMBER: early registration will save you money!

IAIA does not have funds available to pay registration and travel expenses for program participants.

IAIA'04 activities will include training courses, special sessions, workshops, technical visits, social events, and more.

The preliminary program and registration materials will be available on the web site and from IAIA HQ in October 2003.
