The organizer of a proposed theme forum or session is required to submit a registration form, with full conference fees paid, by 28 February 2009. Organizers not able to comply with this requirement will be dropped from the program.

## WELCOME TO ACCRA, GHANA

Accra is the capital of the Republic of Ghana. Located on the Atlantic coast, Accra was originally built around a port, and its architecture ranges from large and elegant 19th Century colonial buildings to modern high rise buildings. Accra is also home to an impressive National Theatre and the Kwame Nkrumah Memorial Park, where independence was declared in 1957.

The University of Ghana, with its distinctive buildings set among elegant tree-lined gardens, is close to the conference venue, just 14km north of Accra. Accra is also known for Makola, the famous large and busy open air market. Three forts and castles, including the famous Christianborg Castle, which is currently the seat of government, all lie within Accra.
