# IAIA 2002 NOMINATION AND ELECTION PROCESS

One-third of the twelve-member IAIA Board is replenished each year through election of a new President-Elect (later President and Past-President) and three new Directors, all of whom serve three-year terms on the Board. All IAIA members are urged to consider nominating IAIA members whom they think would make very good IAIA Board members. To assist with this, the nominations and election process is described below.

The IAIA 2002 nominations and elections process started at IAIA'01 in Cartagena with the appointment of the first Nominations Committee member. Under the current IAIA bylaws, the President and President-Elect are automatically members of the Nominations Committee. Two more appointments of IAIA members to the Nominations Committee will have been made by the Committee Chair, Shirley Conover, before the end of June 2001. Thus the Nominations Committee will consist of two current Board members and three IAIA members in good standing, plus the (non-voting) Committee Chair, who votes only when required to break a tie.

This year the Nominations Committee Chair again requested advice from the IAIA Board concerning Board representation priorities as identified by the current Board. Suggestions included:

- an IAIA member from the United Nations Environment Program (UNEP)
- an IAIA member involved in sustainable development assessment of World Trade and international Trade Agreements
- recognition that IAIA Health Impact Assessment membership has not yet been represented on the IAIA Board
- a number of geographic suggestions: representation from the United Kingdom and/or Ireland, United States, Australia/New Zealand, Eastern European countries, and recognition that South Asia and the Middle East are not yet represented on the IAIA Board
- both strategic planning and networking capabilities are also desired

Two other factors in regard to the new Board must be recognized:

- this year the Board must appoint two of its members with appropriate skills to the positions of Secretary and Treasurer, preferably incoming members who will serve in these vital positions for three years
- the Nominations Committee must take care to ensure a good gender balance on the 2002 IAIA Board.

Throughout the nominations process, the IAIA bylaws direct the Nominations Committee to consider regional, racial, ethnic, gender, experience and professional expertise when contacting potential candidates about their willingness to stand for election to the IAIA Board for three-year terms. Likewise, these same considerations apply when considering which candidates will be finally nominated for each of the four positions to be filled in the 2002 IAIA election. A minimum of two candidates must be nominated for each of the four positions; it is the Committee's decision whether more than two candidates will be nominated for one or more of the positions to be filled.

While the Nominations Committee has responsibility for identifying potential candidates, all IAIA members in good standing (current year's dues paid) may suggest candidates to be considered by the Committee for formal nomination to any of the positions to be filled. Any individual member of IAIA in good standing may serve as a Director or Officer on the IAIA Board. Those elected to the Board are expected to attend all Board meetings (mid-term meeting and those associated with the annual IAIA Conference); communicate electronically with fellow Board members; and be able to obtain their own finance to cover their travel and accommodation costs for these meetings. Currently a small amount of funding is available to support board travel; application may be made for a \$300-\$500 travel stipend on basis of financial need.

It is very useful to know the make-up of the 2001 Board, and which four current members of the Board will complete their terms at IAIA'02 to be replaced by the four individuals elected in IAIA's 2002 election. # THE 2002 NOMINATIONS AND ELECTION PROCESS AND SCHEDULE

#### 1 June 2001

Nominations for President-Elect and Director positions open (at Conference in Cartagena, Colombia).

## 15 September 2001

Last day for receipt of nominations of potential candidates by the IAIA Nominations Committee; Committee members begin to prepare their individual slates of nominees to stand for each position, at least two nominees for each position to be filled.

#### **30 October 2001**

Committee members submit their final slates of nominees to the Committee Chair, who counts and tabulates their votes and presents the result to the Committee members as the draft final slate of nominees for their approval.

#### 1 November 2001

The Nominations Committee presents the approved slate of nominees for President-Elect and three Directors to IAIA's Chief Executive Officer, who will submit the draft ballot to the IAIA Board for ratification and will prepare and supervise the 2002 election process.

### 1 January 2002

Ballots for the 2002 election of the President-Elect and three Directors are mailed to all IAIA members in good standing.

#### 1 March 2002

Ballots for the 2002 election are counted and tabulated; names and positions of the elected Officer and three Directors are announced.
