Current and Ongoing Activities of the Committee 2007-2008

Completed

- 1. Discontinued inactive listservs (Environmental Law and Ethics).
- 2. Provided disclaimer text to the Capacity Building for Biodiversity in Impact Assessment (CBBIA) project coordinators regarding notification of credit on CBBIA guidance documents.

Current/Ongoing

1. Bill Page to ensure that IAPA Online instructions offer the option for either online or e-mail submissions.

- 2. Recruit volunteers for Newsletter Network Contributors. Responsible: Entire committee.
- 3. The IAIA newsletter will add a permanent call for submissions and request for citations for IAPA. Completed/ongoing. Responsible: HQ.
- 4. Review and update the information and instructions for all news contributors as appropriate. Completed/ongoing. Responsible: HQ.

Identification of countries or regions that would benefit from hard copy delivery of resource materials

Preliminary report prepared by Marina Khouteleva based on interviews she conducted with several experts. As needed or as appropriate for follow-up or additional feedback, Marina is willing to send a questionnaire (50 questionnaires) in May 2008.

Screening investigation of regional needs on hard copies of resource materials included: interviews with selected EIA experts/professionals (10 experts in 2 countries). The screening investigation based on the following assumptions:

- The target group is EIA professionals including companies' EHS staff, local consultancies and freelance consultants, competent authorities, NGOs professionally focused on EIA issues. students;
- The target audience has regular access to Internet;
- The group has advanced computer skills and proper software.

The needs on hard copies could be caused by:

Limited Internet access in removed areas (for example, Russian North). Usually, good I-net access through corporate networks (mostly, for big companies but authorities). Sometimes this access supposes limitations on volume of information received (MB). The private access could be organized through modem and be limited by poor phone networks providing slow and unreliable connection.

One has take into account that in removed areas the regular mail is slow (and sometimes unreliable) option as well.

 Cultural sensitivity. Considerable part of professional group prefers using hard copies for example, elder generation (after 40); academicians; sometimes younger generation. Libraries are another users of hard copy materials that is in culture in Russia, Ukraine, Belarus, Central Asian and Caucasus countries.

To conclude, e-copies are considering as the main option for EIA practitioners. The hard copies are useful as an additional option. Key limitations for this option are additional costs and mail service limitations in some areas.
