INTERNATIONAL ASSOCIATION FOR IMPACT ASSESSMENT

PENTA—Promotion of European Education on Environmental Assessment for Third Country Audience

This is an EC-funded Erasmus Mundus cooperation project by the Slovak Technical University in Bratislava, the University of Liverpool, and the Austrian AN!DEA Institute. The project has already produced an SEA textbook, which will be published by Earthscan (www.earthscan.co.uk) in July 2007. A handbook for lecturers and a master degree programme curriculum is currently being written, based on current EU member state EA programmes.

The project partners held a workshop in Bratislava on 20 February with university representatives from Hungary, Germany, Italy, Austria, and the UK, and two conferences will be held for third country audiences, one in Graz in April 2007 and one in Dehradun, India, in September 2007.

Snapshot of SEA Progress Across the European Union

The European Environmental Bureau (EEB) has published a “snapshot” report on the quality of transposition of the EU SEA Directive, focusing on biodiversity. The report summarises survey results of NGOs from eighteen countries.

The findings suggest that although SEA has improved some planning practices, it has not reached its full potential. The Directive has not been transposed into national law in some countries. Where it has, significant legal gaps often appear to exist, and the quality of application is often low. The opportunity to address biodiversity at the strategic level is often missed. Actions recommended to national governments include developing national guidance on preparing environmental reports, and supporting meaningful NGO participation. NGOs still have high expectations for SEA and hope it will contribute to the EU’s commitment to halting biodiversity loss by 2010.

What's in a Membership

Successful professional organisations retain their members and grow their membership. Turnover within the membership is to be expected as careers and people's interests move on and change. However, whilst IAIA has been the association of choice for many IA professionals and our organisational network has benefited from their loyalty and intellectual participation, many individuals have only been "1 year conference" members and then disappeared off Rita's radar.



We have to look more widely at what role IAIA can play in enhancing the future careers and professional development of our members.

I welcome your feedback.

In a world where development is increasingly viewed by planners as the route to social prosperity, the importance of IA tools, IA-backed strategic plans and increasingly our input into sustainable development and climate change adaptation will be of increasing importance—but only if people know about us and are willing to bring us to the table and hear our views. It should therefore be a matter of concern to all of us that IAIA, although seeing a steady growth in membership over the last few years, has been unable to retain contact with so many promising IA individuals after conferences.

The conferences play a key part in our annual membership recruitment, and although they have a distinct geographic impact on annual membership, they also have a net benefit across the wider international membership. The post-conference feedback from both established and new contacts is always positive and although there are recognised issues regarding the time allotted to papers and the quality of some presentations, the conferences remain a key parameter of why people become (or remain) members. It also cannot be from the lack of *bon humour* in our meetings—as I feel they remain one of the friendliest events on the environmental calendar!

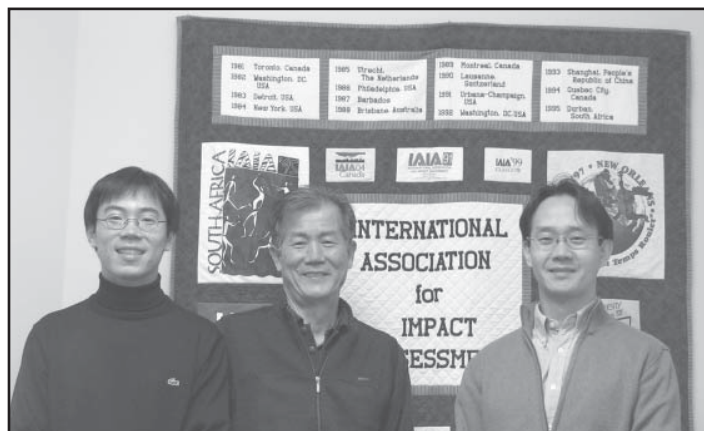
No, the issue I feel is that we have to look more widely at what role IAIA can play in enhancing the future careers and professional development of our members and what mutual links can keep both individual and IAIA in contact. It is therefore time to look at a new mechanism of how we can structure the membership categories and what benefits members gain through these structures. We also need to review how IAIA can assist the professional status of IA practitioners—as IA consultants, IA administrators and as IA trainers. This needs to consider start-of-career professional development, training and subsequently continuous professional development (CPD). We need to evaluate how we develop long-term links with members, reward them for that loyalty, and recognise the contribution they are making. We need to examine IAIA's networks and our profile within national IA organisations and with practitioners and IAIA affiliates. Finally, there are new tools that can be included through our Web site in the future; we need to consider what our Web presence can bring regarding job opportunities, conferencing, webstreams and information availability.

I would therefore welcome your feedback on what steps IAIA should consider and how these could be structured to the benefit and continuity of members. I feel that there is an imperative to act and I would like to put together a proposition to the Board and ultimately yourselves on how we move forward.

IAIA Ghana Chapter – News Highlights 2007

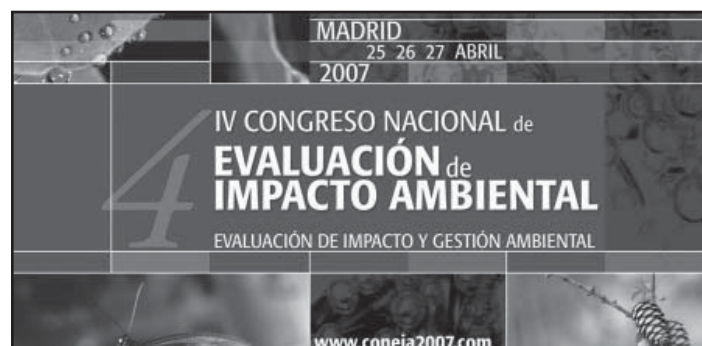

NZAIA Annual Conference

Relevant, accessible, practical, worthwhile and fun featured in attendees' descriptions of the two-day New Zealand Association for Impact Assessment conference in Dunedin, December 2006. The topic, "Assessing the Impacts of Energy Development: Regional and Local Perspectives," was timely as several power generating companies are searching for and applying for resource consents to erect wind turbines, build hydro electricity, and develop natural gas, oil and coal as sources of electricity and other forms of energy in this nuclear-free country.

The programme began with the Parliamentary Commissioner for the Environment, Dr. Morgan Williams, providing a keynote address focussed on "decarbonising" New Zealand's energy future in the search for higher levels of sustainability. The need for strategic approaches and impact assessment were then considered, and considered important, particularly at the regional level.

Then a number of speakers from New Zealand and Australia considered different aspects of impact assessment including visual, noise, air quality, recreation and tourism, aquatic ecology, workforce and community aspects, with reference to wind farms, fossil fuels and hydro-electricity developments in particular. The final sessions included consideration of consultation, Maori and community partnerships as well as monitoring, mitigation and follow up studies.

The small dynamic conference worked well thanks to the effort of organiser Richard Morgan and his team. Throughout the conference emphasis was placed on excellent presentations by invited speakers and plenty of discussion amongst the participants. In addition, students and practitioners were encouraged to present their work via poster papers. There was an AGM and the conference ended with an "Indaba" to set directions for the affiliate for the next year. A CD of the proceedings was produced.

Held at a residential college at Otago University, the facilities were quiet, comfortable and well priced. As many New Zealanders have studied at Otago, there was also an opportunity to stay with or catch up with friends. New Tech Forecasting & Assessment (TFA) Forum

The FTA Forum has now been launched, building upon the recommendations to advance the FTA community and its processes, which stemmed from the Second International Seville Seminar on Future-Oriented Technology Analysis (FTA): Impacts on policy and decision making, 28-29 September 2006.

Professional Activities

The objectives of the FTA Forum include the following:

- To provide an open space for dialogue between different (yet overlapping) communities, such as foresight, technology assessment, futures studies, technological forecasting, evaluation, quality management, etc., with a view to promoting mutual understanding.
- To nurture the development of a self-organisation capacity within the FTA community.
- To identify needs within the FTA community and to enable mutual support between its members.

The FTA Forum has been designed in such a way as to address an initial set of issues that emerged from the FTA Seminar. These are issues that need careful attention and a continual active dialogue to enable a better understanding of where the FTA community stands today and what is needed to move forwards. Other issues that were raised at the FTA Seminar have been kept back for a second round of discussion. You are therefore encouraged to build on this initial set of issues but are also free to propose new issues for future rounds of discussion.

The FTA Forum will be moderated in cooperation between the 2006 FTA Seminar Technical Committee members and IPTS. New Open Educational Resource on Strategic Environmental Assessment

A new open educational resource on strategic environmental assessment is now available at the UNU Online Learning Website (see <http://www.onlinelearning.unu.edu/sea/index.html>). This resource was developed collaboratively by Oxford Brookes University and the UNU. It was officially launched in February 2007 and will be used in the Masters Degree programme on Development Management developed at the UNU-Global Virtual University later this year. The open educational resource includes a course module, encyclopedia (wiki) and instructional guide and can be used freely by universities and individual learners around the world. The course materials were authored by Prof. Riki Therivel at Oxford Brookes University. Professor Therivel is an internationally recognized SEA expert and has written numerous books on topic. The course module, which was built in Wordpress (<http://wordpress.org/>), also incorporates video interviews with a number of subject matter experts including John Glasson (Oxford Brookes University, Maria Rosario Partidario (Technical University of Lisbon) and Chris Wood (University of Manchester). Learners interested in obtaining a certificate based on the course materials can apply to Oxford Brookes University (<http://www.brookes.ac.uk/schools/be/oisd/environment/iau/index.html>). Others universities are planning to launch programmes based on this SEA open educational resource including the University of the South Pacific based in Fiji. 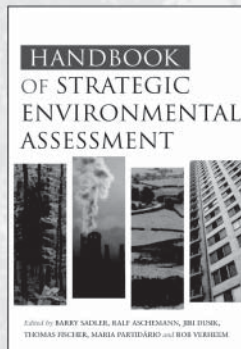

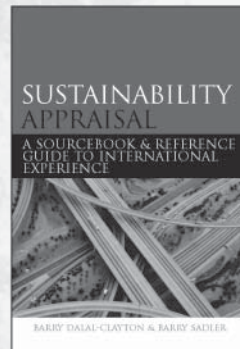

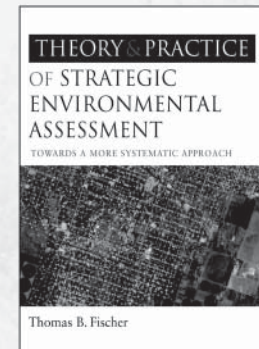

In Memory

It is with regret that we announce the passing of **Dr. Shirley Conover** (July 9, 1929 – January 8, 2007).

Shirley had a distinguished scientific career and we are thankful for her significant contribution to environmental impact assessment in Canada and internationally. She received a PhD from Dalhousie University in Halifax and an MSc from Yale University, both degrees in biological oceanography. She began her environmental impact assessment career working for a consulting firm that conducted assessments of proposed oil and gas developments in the 1970s and 80s in the Canadian east coast offshore. She was a Lester Pearson Senior Fellow at Dalhousie University and project director of the University's Environment and Resource Management programs in the Philippines and Indonesia. These programs involved policy and program development and education and training in the area of environmental management including environmental impact assessment. During this time she also served as the Chair of the Environmental Assessment Panel that reviewed the Halifax Harbour Clean-up project which was completed in 1993.

Shirley's talents were frequently in demand, which led to her serving on various government committees including the Canadian Environmental Assessment Research Council, the Canadian Environmental Advisory Council, the Energy Mines and Resources Regulatory Review Panel, and the Natural Sciences and Engineering Research Council. She also was an active member of IAIA, and served as a Secretary on the Board of Directors. In 2002, she was awarded the Rose-Hulman award in The Hague in recognition of her contribution to environmental impact assessment over a period of many years. 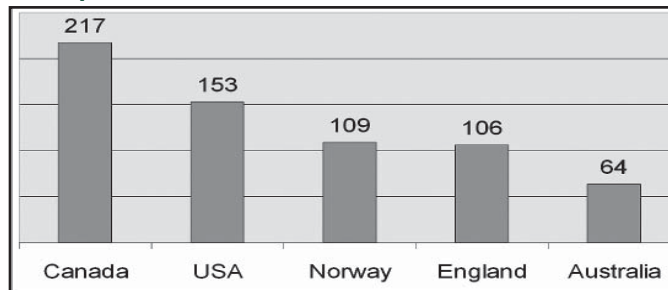

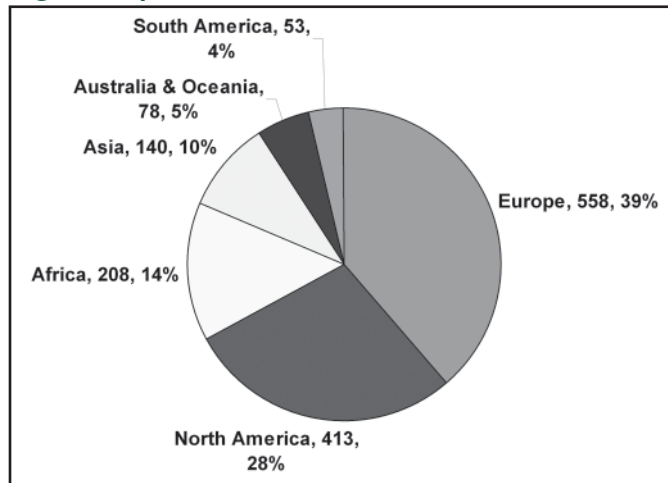
Membership Snapshot
