## INTERNATIONAL ASSOCIATION FOR IMPACT ASSESSMENT

### Centre of SEA for China Established at Chinese University of Hong Kong

A new Centre has recently been established at the Chinese University of Hong Kong to promote SEA and build capacity in impact assessment in China. The establishment of the Centre is timely and significant. China is facing a number of critical environmental and resources issues while grappling with double-digit economic growth and significant regional disparity. The need to mainstream sustainability consideration in national development strategy was underscored by senior government officials in the SEA Conference organized by the State Environmental Protection Administration (SEPA) in Beijing in November 2007 with strong presence at that meeting by IAIA. Being the recipient of the IAIA Regional Award in 2000, the Chinese University of Hong Kong is strategically positioned to embark on this important mission given its knowledge of, and connections in, China and experience of working with SEPA, international agencies, IAIA and other SEA institutions. ### UK Government to Be Challenged in Europe over EIA Screening

The UK Government's decision not to require Environmental Impact Assessment (EIA) for a proposed medium-security hospital at the former Royal Navy base HMS Forest Moor in Nidderdale, near Harrogate, North Yorkshire, is set to face a legal challenge in the European Court of Justice. The site lies within the Nidderdale Area of Outstanding Natural Beauty (AONB); local objectors, led by Christopher Mellor, maintain that an EIA should be carried out in order to protect the environmental interests of the AONB. Mr. Mellor argues that former Communities Secretary Ruth Kelly failed to give adequate reasons for the decision not to seek an EIA.

In January 2008, in R (Christopher Mellor) v Secretary of State for Communities and Local Government, the Court of Appeal decided to refer to the European Court of Justice to determine whether reasons have to be given for screening decisions that Environmental Impact Assessment is not required. It is the second time objectors to the scheme have brought the case to the courts. In May 2006, Harrogate Borough Council backed down to the first legal challenge to its decision not to require EIA, and consented to the planning permission being quashed. It then decided in October 2007 that EIA was required, only for the Secretary of State to direct in December 2007 that no EIA was necessary. For more information:

## From the President

At the risk of opening up Pandora's box, I wish to generate some debate on a question that has come up at several meetings, directly in the summary plenaries and in many IAIA conference sessions, for as long as I have been a member of IAIA. I sense that most of us recognize and appreciate the need for addressing social and poverty concerns, health issues, cultural resources, biodiversity or climate change in our impact assessment work. For example, poverty and social issues was the most commonly cited topic of interest (after climate change) in the President Elect's survey of the membership last year at about this time.

Some of us operate under laws, regulations or procedures that define "environment" broadly; a comprehensive consideration of issues is required as part of the "environmental" impact assessment (EIA) process and document. Addressing these concerns within the EIA process has advantages. Most processes are based on law or regulations, are structured, incorporate public, agency and other stakeholder consultations, have formal reviews, result in the public disclosure of documents and lead to an approval or permit. All issues are then part of this same process and the "environmental" management plan is subject to regulatory agency follow-up and monitoring. The downside is that some issues, such as health or poverty or cultural resources, may not be properly vetted and discussed by those agencies with responsibilities and expertise in the subject matter. Or the EIA may not have been prepared with sufficient expertise for some of the issues. Perhaps some issues may be better dealt with at a macro level and not in EIA, SEA or even sustainability assessment. Does this then argue for separate social or health impact assessments or separate biodiversity assessments? Are there criteria for determining when to lump and when to split, i.e., when to have separate assessments, such as HIA or SIA, even if this might exclude them from a regulatory process?

Please contact me ([binghamc@mcc.gov](mailto:binghamc@mcc.gov)) and tell me how the process works in the country (or state/province) where you live and/or work. Are several types of impact assessments prepared? What works and what does not? I would like to propose a roundtable at IAIA09: Impact Assessment and Human Well-Being to discuss the topic of lumping or splitting—advantages and disadvantages. If there is interest, I will post updates in the coming year's newsletter on this topic.

I have enjoyed being the IAIA President for 2007-2008 and thank all of you for the feedback you have provided. I especially wish to thank the members of the Board for 2007-2008 for their support and hard work and the dedicated staff of IAIA headquarters. ## IAIA-WNC Holds Conference on Cultural Impact Assessment

Assessing impacts on culture was the theme of a recent conference held by IAIA's Western and Northern Canada Affiliate (IAIA-WNC). Titled "Cultural Impact Assessment: Beyond the Biophysical," this sold-out conference was held in Yellowknife, in Canada's Northwest Territories, from 28-29 February 2008. The conference brought together 100 EIA professionals and academics from government, Aboriginal communities, industry, NGOs and academia from across the country. Subjects included:

- Identifying and mitigating cultural impacts
- Using indigenous knowledge in impact assessment
- Understanding cultural landscapes
- Assessing impacts on intangible cultural resources
- Overcoming common hurdles in cultural impact assessment

In the evening, participants enjoyed an exciting demonstration of traditional Aboriginal hand games and participated in a drum dance.

## IAIA-WNC Presents Lifetime Achievement Award in EIA to Gwich'in Elder Charlie Snowshoe

The Western and Northern Canada Affiliate of IAIA awarded its first annual Lifetime Achievement Award to Gwich'in Elder Charlie Snowshoe. The Affiliate's executive committee and regional directors from Saskatchewan, Alberta, British Columbia, the Yukon and the Northwest Territories (NWT) unanimously selected him for the award.

Charlie Snowshoe lives in the tiny arctic community of Ft. McPherson, NWT. He is an active traditional harvester with a deep love of the land. Snowshoe has been instrumental since the 1970s in carving out a strong role for Aboriginal people in environmental decision making.

Charlie Snowshoe was one of the original fighters for the Gwich'in Land Claim, and the Gwich'in Land Use Plan. He served on the Hunters and

Trappers Panel for the historic Berger Inquiry in the 1970s. He has been a dedicated board member of the Mackenzie Valley Environmental Impact Review Board (MVEIRB) since its creation in 1998, where he has been influential in several precedent-setting decisions.

The award was presented by affiliate president Alan Ehrlich, at the MVEIRB EIA Practitioner's Workshop on 26 February 2008. Media were present in abundance, including two TV stations, national radio, a monthly magazine and newspapers.

In presenting the award, Ehrlich said that Snowshoe was receiving the award "...For seeing beyond the legal detail, to shine the spotlight of decision-making squarely on the big picture: What is best for the land and the people? What is the right thing to do for the long haul?...For all the wisdom

you bring to making decisions about Environmental Impact Assessment."

Snowshoe's humorous and heartfelt acceptance speech was followed by a two-minute standing ovation.

## Environment and Strategic Environmental Assessment Report from the 1st National Congress of IAIA-Italia

The First National Congress on Strategic Environmental Assessment (SEA) was organized by IAIA-Italia at the University of Venice from 21-23 February 2008.

More than 150 members from over all the country attended the congress. Among the attendees were local and regional managers, environmental control agency personnels, and students and professionals dealing with environmental issues and SEA.

Prof. Michael Schlesinger, a worldwide climate change expert, addressed the delegates on the first day of the congress and presented his latest book, *Human-Induced Climate Change: An Interdisciplinary Assessment*. In the following two days, Prof. Leonard Ortolano of Stanford University explained procedures and concepts of environmental assessment from 1970 to 2008. Ortolano's presentation was much appreciated!

Other topics of the congress:

- National Legislation of SEA
- Models, methodologies and information systems used for SEA
- The relationship between environmental assessment and management, control and monitoring
- The relationship between SEA and biological landscape ecology
- Indexes and indicators for SEA
- Satellite remote sensing and satellite imagery as SEA knowledge baseline source
- Space decision support systems

Giuseppe Magro, national IAIA-Italia President, introduced the IAIA-Italia program for SEA and in particular the opportunities of GIS applications for impact assessment in Italian administrations.

Prof. Virginio Bettini, President of the IAIA-Italia Scientific Committee, introduced an innovative SEA frame for the Via Francigena historical route.

The congress closed with Prof. Falqui from the University of Florence, who summarized the key concepts of the three-day congress. In his remarks, Prof. Falqui also complimented IAIA-Italia for having organized such an event, the first one in Italy, and expressed his hope that the Association continues its activities, including hosting an IAIA global conference in Italy. • For information, contact [info@iaiaitalia.it](mailto:info@iaiaitalia.it).
