Report from SIA Section Co-Chairs

Activities at IAIA'12

- IAIA'12 was another active conference for the section. The section was involved 19 sessions, including 2 theme forums and another 5 sessions within the conference theme.
- The section has continued to collaborate with other IAIA sections (Indigenous Peoples, Corporate Stewardship and Risk Management, EIA and Health).
- IAIA connect was used (in addition to the section meeting in Puebla) to generate session ideas and develop and coordinate proposals.
- Topics discussed at Porto include: FPIC, partnerships, HRIA, gender, community responses to energy development, resettlement, SIA policy and Social Impact Management Plans.
- The SIA section supported a successful nomination for the corporate achievement award for 2012. The award was won by Anglo American for their Social and Economic Assessment Tool.
- The section also participated in a meeting hosted by the Biodiversity section at Porto to further collaboration on ecosystem services.
- Section members, Frank Vanclay and Ana Maria Esteves again hosted a training workshop on SIA at this year's conference.

Ongoing Projects

- The SIA section are continuing to develop International Guidelines on SIA. The project is being led by Frank Vanclay.
- The SIAhub, an online portal for SIA practitioners, established with the support of an IAIA Challenge Grant, was launched in early 2011. The development of the site was driven by Ana Maria Esteves and is overseen by a management group. The site has more than 250 subscribers, of whom two/thirds were not in IAIA thus confirming that it would not detract from IAIAconnect and that it would bring SIA practitioners into IAIA.
- A book titled 'New Directions in Social Impact Assessment' was published by Edward Elgar in late 2011. The book was edited by Frank Vanclay and Ana Maria Esteves and includes contributions from many of SIA section members.

New Projects

- In collaboration with the Corporate Stewardship and Risk Management section, the SIA section supported the development of a special issue of IAPA on the topic of human rights and impact assessment to appear in 2013. The issue will be guest edited by Deanna Kemp and Frank Vanclay (both SIA section members).
- Section members contributed a paper on SIA to the special issue of IAPA on The State of the Art of Impact Assessment.
- SIA section members are supporting a two-day workshop of practitioners and academics to be held in Australia in 2012 on 'State of the EIA'.
- The SIA Section has started a Twitter account (@SIA_IAIA). The feed currently
 has a modest total of ~170 followers. The Section suggested expansion of the
 use of Twitter at the Porto conference and worked alongside the conference
 team to do so.
- Daniel Franks is participating in the peer review of the Commonwealth Secretariat guidelines on foreign investment as part of the working group on environmental and social impact assessment. A meeting of the working group is being held in London the week following IAIA'12.

Challenges to the section

- The section has at times been relatively active on IAIA connect, but is still
 coming to terms with the potential of the portal and the role it could play in
 between conferences to foster networking and activities. A number of
 networking attempts have not generated active participation.
- The section has unrealized ambition to play a greater role in networking practitioners between conferences.
- One issue raised on IAIA connect by section members related to the role IAIA
 could play in promoting the importance of social qualifications for social
 impact assessment roles in international organisations. This issue was raised
 due to a number of job advertisements that advertised positions responsible
 for SIA without requirements for social qualifications.

Links with other sections

 The SIA section in recent years has developed good collaborative relationships and joint conference sessions with the Indigenous Peoples, Corporate Stewardship & Risk Management, Public Participation, Biodiversity, EIA and Health sections. The section anticipates that it will expand on these connections.
